

About the Delivery Program 2022–2025

Functional Areas

We have had 939 people participate in library activities during this reporting period, 86 new library members sign up, 8,348 visitors to the library and 5,514 items borrowed which is a pleasing result. A strong working partnership with Gralee School has been formed with students and staff attending the library weekly on a Tuesday for a special story time for their students. An English Hel Program held weekly on a Monday and a Thursday for designated timeslots was launched primarily targeted at our refugee and migrant communities which has been well patronized since commencement. Additional support funding has been applied for and gained for inclusion support to help facilitate growth to the service which is very pleasing for local families. The service cared for 57 children over the above dates. Leeton Vacation Care (VAC) is a 50 child per day service, opened during school holidays from the dates of 4 July 2022 until 15 July 2022 the service catered to 89 children with a 47.75% occupancy capacity (62% in Q4 last year). Again, with our regular staffing structure back from maternity leave in early 2023, we will look to increase awareness and grow this service. 
