

Contract Register

The Government Information (Public Access) Act 2009 is designed to meet community expectations for more open, accountable and transparent government. The Act requires councils to record and publish information about contracts when entered into with the private sector. A register of government contracts is mandatory open-access information, required under sections 6 and 18 of the GIPA Act. How this information is made available is prescribed in Part 3, Division 5 (sections 27 - 40 inclusive). The register must be published on Council's website and made public in any other way Council decides. Last Update: April 2024

- That wasn't awarded as the result of a tender process but:
 - Was negotiated directly with the contractor, and
 - The contract isn't publicly disclosed.
- That was awarded from a tender but whose terms and conditions have been substantially negotiated with the successful bidder.
- Under which obligations to maintain or operate infrastructure or assets will continue for 10 years or more.
- That involves a 'private financed project' as defined by the Treasury (TPP 17-07 NSW PPP Guidelines).
- Which involves the transfer of a significant asset to another party in exchange for another asset.
